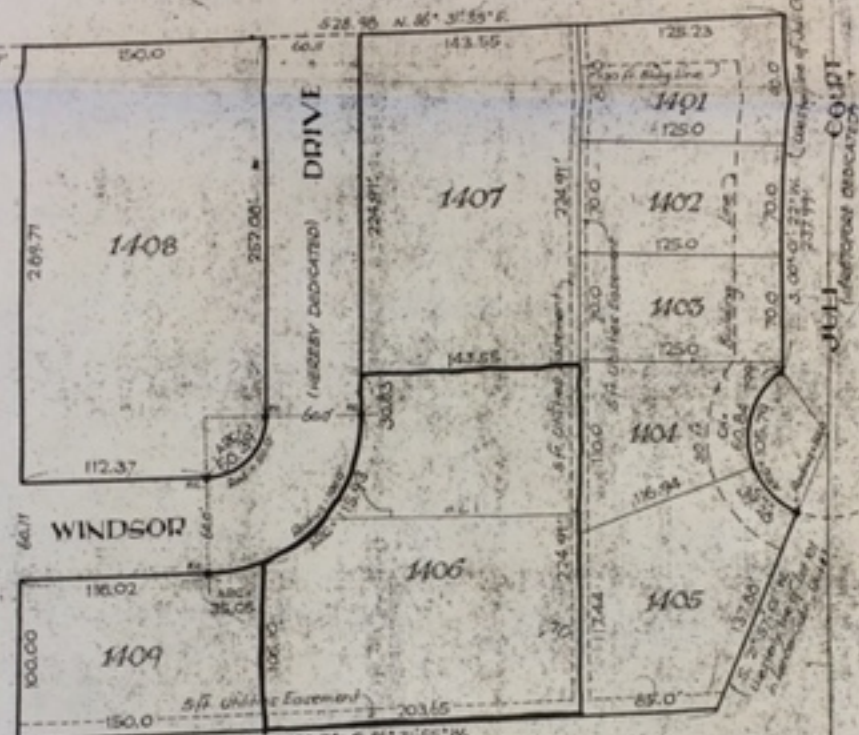


WEATHERSFIELD (HEREBY DEDICATED) (SCULLY DR) WAY
