

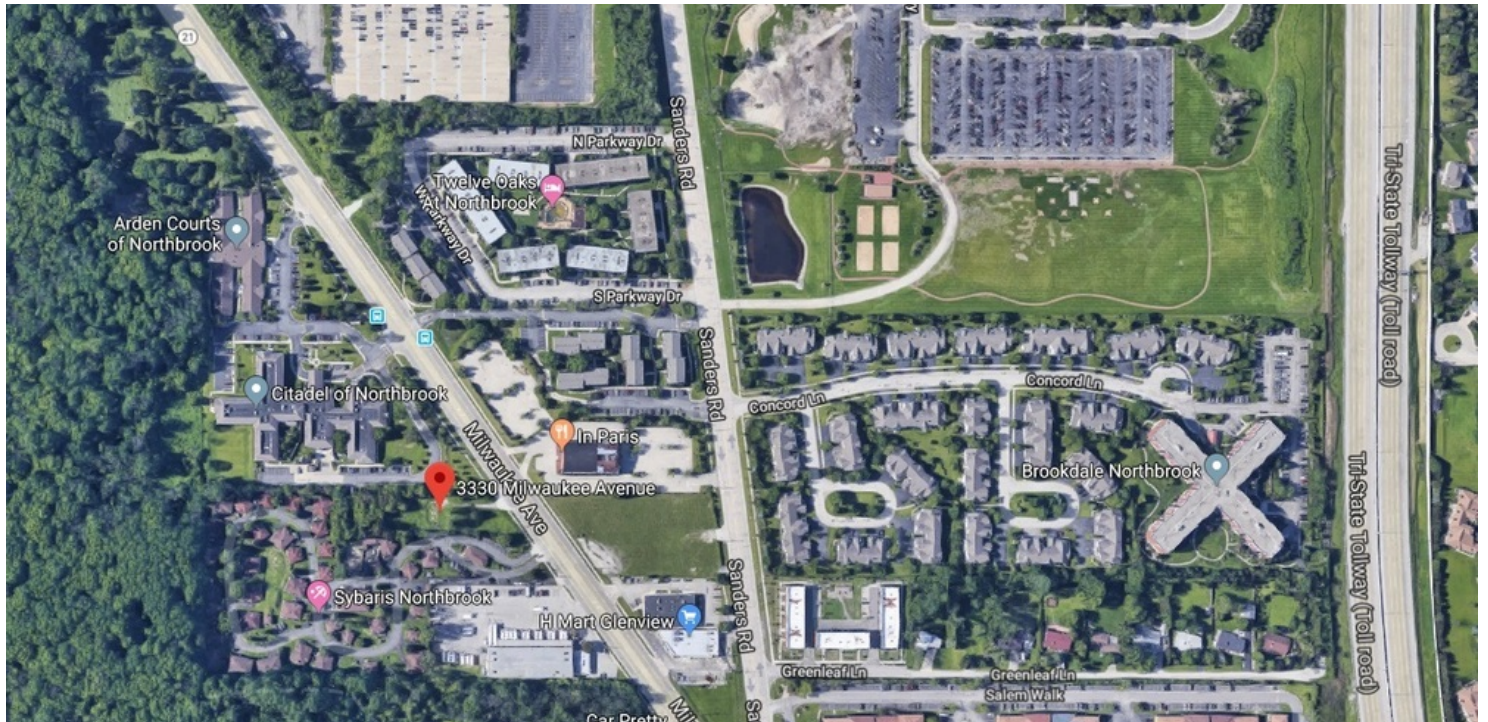

## LOCATION OVERVIEW

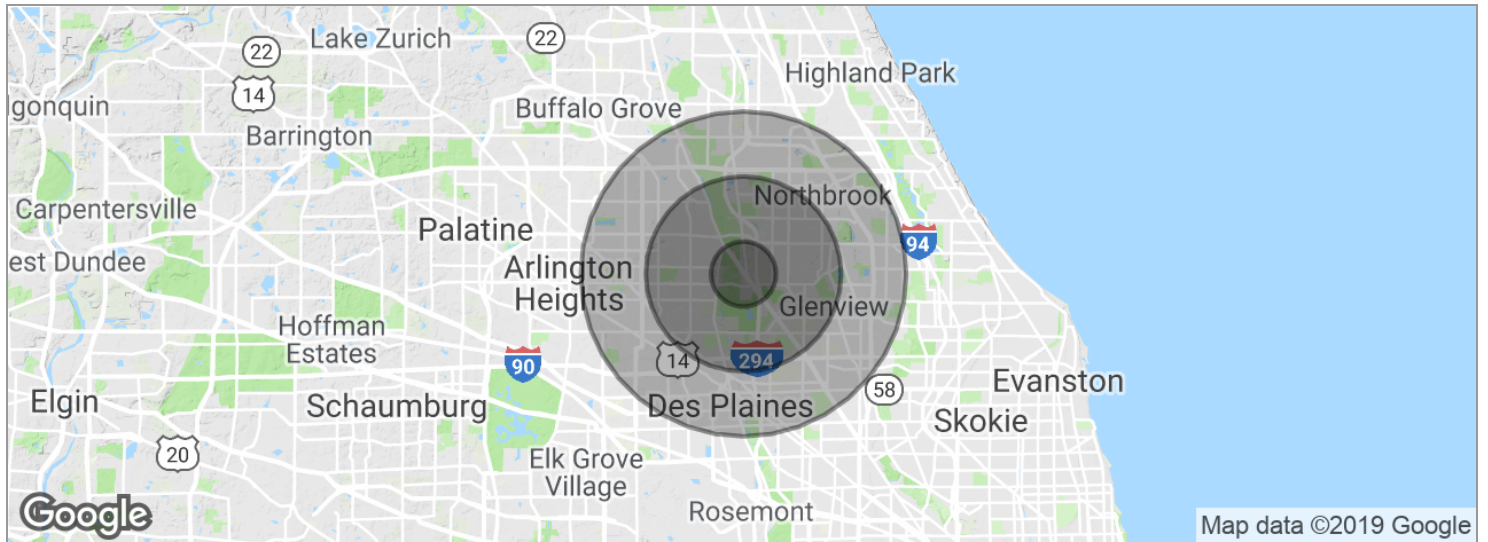
